JONATHAN REINSVOLD highlighted the Village's school zone speed enforcement camera system and spoke optimistically about safer schools moving forward.

BRIAN RUSCHER, Deputy Director of Multimodal, presented this update. The newly created Crash Reporting Toolkit as well as other safety resources are available at <a href="PalmBeachMPO.org/Safety">PalmBeachMPO.org/Safety</a>.

JASON KAUFMAN inquired about coordination of the Crash Dashboard with local police, noting that the State's Signal4 platform is not always a reliable source to determine crash locations.

NATALIE CROWLEY encouraged collaboration and cross-training with diverse audiences to enhance messaging and acceptance of these resources.

KIM DELANEY shared an experience of convening an all-staff meeting, allowing a diverse audience to convene and benefit from discussion of safety materials.
