MPO Governing Board Officers

- The officers of the MPO shall consist of a Chair, a Vice Chair, and three at-large Representatives of the Governing Board.
- Together, the officers shall be referred to as the Executive Committee. Not more than two of the officers may be County Commissioners.
- The officers shall be elected annually at the last regularly scheduled meeting of the calendar year.
- The newly elected officers shall take office on the first day of the following calendar year.
- Additional elections may be held as necessary if an officer cannot carry out said officer's duties and complete the remainder of the appointed term.

Chair Requirements

- The Chair must have served on the Palm Beach MPO Governing Board as a Representative for at least one year before taking office.
- The Chair must have completed MPOAC Institute training, attended a national AMPO Conference, or received comparable training within the past four years.



Chair Duties

- Leads Palm Beach MPO Governing Board meetings and sets the order of business.
- Signs official Palm Beach MPO documents.
- Approves authorized travel reimbursements, ensuring advance approval and cost-effective travel.
- Serves as the Palm Beach MPO's Southeast Florida Transportation Council (SEFTC) and Metropolitan Planning Organization Advisory Council (MPOAC) Delegate.

Vice Chair Requirements

- The Vice Chair must have completed MPOAC Institute training, attended a national AMPO Conference, or received comparable training within the past four years.
- In the Chair's absence, the Vice Chair shall preside and carry out all other duties of the Chair.



Vice Chair Duties

- In the Chair's absence, the Vice Chair shall preside and complete all other duties of the Chair.
- The Vice Chair shall serve as the MPO's SEFTC and MPOAC Alternate Delegate.
- If the Chair is unable to carry out their duties for the remainder of the term, the Vice Chair shall automatically become Chair, and a new Vice Chair shall be elected from the remaining eligible representatives for the remainder of the term.
